1. The purpose of this modification is to revise Clause H.19 Economic Price Adjustment – Price Refreshment of the contract.
2. The contract is modified to revise Clause H.19 Economic Price Adjustment – Price Refreshment. The three primary changes to the clause are:
  - The Government will adjust the prices versus the contractors.
  - The contractors will not be permitted to revise the adjusted prices as part of the price refreshment.
  - The prices for Cloud Services will not be adjusted since they are catalog prices.
