

1. The purpose of this modification is to:
  - a. Clarify that agencies are allowed to specify additional verification and acceptance testing.
  - b. Remove BSS requirement to support Internet Explorer.
  - c. Update version number in a security document reference.
  - d. Clarify data coding for feature changes that do not require CLIN changes.
  - e. Update requirements to allow administrative values to be added or removed via SOAC.
  - f. Update XSD and WSDL attachments to include consistent property requirements for agency\_identifier and unique\_billing\_identifier.
  - g. Permit omission of CSRN in dispute files when not applicable.
  - h. Correct the edit mask in the billing\_quantity data element definition.

2. The contract is modified as follows:

### **Section E**

1. Section E.2.2.5, first sentence of first paragraph, is modified to append the phrase “including any additional testing defined in the TO.”
2. Section E.2.2.5, second sentence of first paragraph, is modified to append the phrase “including any additional testing defined in the TO.”
3. Section E.2.2.5, second bullet, is modified to append the phrase “including any additional testing defined in the TO.”
4. Section E.2.2.5, first sentence of the paragraph after the bullet list, is modified to append the phrase “including any additional testing defined in the TO.”
5. Section E.2.2.5, last sentence of the paragraph after the bullet list, is modified to append the phrase “including any additional testing defined in the TO.”

9. Section J.2.10.1.1.4.2.3 is modified to delete the phrase “or features” from the end of the first sentence.
10. Section J.2.10.1.3.3.1 is modified to replace the attachment. The new attachment contains updated XSD files for the DBAS and SOAC data sets. All other files in the attachment are unchanged. The DBAS and SOAC files are modified as follows:
  - DBAS - agency\_identifier properties are updated to reflect the fixed length values in use
  - SOAC - unique\_billing\_identifier properties are updated to include a new restriction matching those found in other files
  - SOAC = properties for change\_value\_from and change\_value\_to are updated to allow these fields to be omitted or left empty if required

11. Section J.2.10.1.3.3.2 is modified to replace the attachment. The new attachment contains updated WSDL files for the DBAS and SOAC data sets. All other files in the attachment are unchanged. The DBAS and SOAC files are modified as follows:
    - DBAS - agency\_identifier properties are updated to reflect the fixed length values in use
    - SOAC - unique\_billing\_identifier properties are updated to include a new restriction matching those found in other files
    - SOAC = properties for change\_value\_from and change\_value\_to are updated to allow these fields to be omitted or left empty if required
  12. Section J.2.10.2.1.9, the table row for Element Name contractor\_service\_request\_number, column Value Requirement is modified to read "If Applicable" vs "Always."
  13. Section J.2.10.2.1.17 is modified to insert the following after the bullets: "If the updated field has no current value, change\_value\_from may be omitted. If the intent is to delete a current value and leave the field blank, change\_value\_to may be omitted. In all other cases both fields are required to have a valid value."
  14. Section J.2.10.2.1.17, the table row for Element Name change\_value\_from, column Value Requirement is modified to read "If Applicable" vs "Always."
  15. Section J.2.10.2.1.17, the table row for Element Name change\_value\_to, column Value Requirement is modified to read "If Applicable" vs "Always."
  16. Section J.2.10.3.1.2, row for Element Name = billing\_quantity, is modified to insert an additional "N" at the beginning of the Edit Mask so that it now reads: "NNNNNNNNNNNNNNNNNN.NN" (17 Ns before the decimal vs 16).
