1. The purpose of this modification is to incorporate BT Federal Inc.'s Submission Number BT00812.01a dated November 17, 2020 into the contract. The submission adds a new Access Arrangement (AA) Monthly Recurring Charge (MRC) price associated with CLIN AA00310 (Dedicated Ethernet 50Mbps) to existing PHubs previously awarded. The new CLIN price for the existing PHub results in new AA MRC prices (at all NSC's associated with the Phubs). Additionally, Audio Conferencing Service (ACS) CLINs are added.
